Employers are required by law to perform certain duties designed to reduce the potential risk to employees' health. These duties are set by COSHH; a collective of helpful guidelines set by the government.

COSHH Regulations 2002 grew from an earlier piece of legislation, introduced in 1988, designed to place more focus on the dangers associated with hazardous substances and the measures employers should take to reduce such risk.

COSHH has played an important part in improving safety standards, raising awareness of the risks and giving employers an incentive to ensure that their workplace is as safe as possible.
